The main outcomes of this activity will therefore be a broader knowledge and awareness of existing materials on the impact of youth work and non-formal learning practices as well as existing recognition tools and practices, an increased level of awareness and understanding of participants' backgrounds and national realities and, in the end, a plan of action devised by participating organizations and institutions for concrete future measures.
